

## PRIVACY NOTICE

### Introduction

The Data Protection Act 2018 (DPA 2018) sets out the data protection framework in the UK and incorporates Regulation (EU) 2016/679 (General Data Protection Regulation, "GDPR") into national law. Its purpose is to protect the "rights and freedoms" of natural persons (living individuals), and to ensure that personal data is not processed without their knowledge, and, wherever possible, that it is processed with their consent.

Where Lambert Smith Hampton is defined as the Data Controller, we have a legal duty to protect any information we collect from you. We use appropriate technologies and organisational measures to safeguard your data and keep to strict security standards to prevent unauthorised access to it.

All information will be processed in accordance with the applicable data protection laws in the United Kingdom applicable to the processing of Personal Data and the interception of communications in place from time to time, including (i) the Data Protection Act 2018, (ii) the General Data Protection Regulation as it forms part of domestic law in the United Kingdom by virtue of section 3 of the European Union (Withdrawal) Act 2018 (including as further amended or modified by the laws of the United Kingdom or a part of the United Kingdom from time to time) (the "GDPR"), and (iii) any relevant law implemented as a result of GDPR (together "Data Protection Laws").

### Overview

This Lambert Smith Hampton (LSH) privacy notice provides information on how LSH and any of its subsidiaries, branches or representative offices and any 3rd party providers collect, use, secure, transfer and share your information. LSH, and its affiliates, is a leading provider of commercial property agency, property management, auctions and consultancy services. It operates in over 30 locations with over 1000 employees within the United Kingdom.

Lambert Smith Hampton takes data protection very seriously. The use of the internet pages of LSH and its subsidiaries/branches is not possible without the provision of some personal data; however, if a Data Subject wishes to use certain services via our website, processing of further personal data could become necessary. If the processing of personal data is necessary and there is no statutory basis for such processing, we will obtain consent from the Data Subject.

Personal Data processing shall always be in line with current UK Data Protection Laws and in accordance with the country-specific legislation applicable to LSH. By means of this Privacy Notice, we inform you why we collect and process personal data and Data Subjects rights relating to the collection and processing of Personal Data.

## Definitions

The following definitions apply:

**Controller:** the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data, where the purposes and means of such processing are determined by Union Member State Law, the controller or the specific criteria for its nomination may be provided for by Union or Member State law.

**Personal Data:** any information relating to an identified or identifiable natural person (Data Subject). Any information that identifies you personally i.e. your name, email address, internet protocol (IP) address etc.

**Data Subject:** any identified or identifiable natural person whose personal data is processed by the controller responsible for the processing. An identifiable natural person is one who can be identified directly, or indirectly, in particular by reference to an identifier such as name, identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person.

**Processor:** a natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller.

**Third Party:** a natural or legal person, public authority, agency or other body, other than the data subject, controller, processor and person who, under the direct authority of the controller or processor, are authorised to process personal data.

**Processing:** any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination, or otherwise making available, alignment or combination, restriction, erasure or destruction.

**Consent:** consent of the data subject is any freely given, specific, informed and unambiguous indication of the data subjects wishes by which he or she, by a statement or a clear affirmative action, signifies agreement to the processing of personal data relating to him or her.

LSH processes personal information to enable us to provide our full range of services, promote our services, maintain our accounts and to support and manage our employees. ## Methods of collection

In the general conduct of business, LSH collects information relevant to the services being sought across the range of services it offers (listed on our website) from:

- Yourself (the data subject), and/or Next of kin, spouse, partner, family member
- The LSH and its affiliates' Websites
- "trusted" sources including:
  - Property portals
  - Government/Land Registers
  - Insurance companies
- Through consent to third parties disclosing information about you to us that they have collected.

Such information will generally be collected directly via the use of any of our standard forms, over the internet, via email, in our offices or through a telephone/video conversation with you and/or the sources mentioned above. On occasion, call/video recordings may be made, but you will always be notified of this prior to any recordings. We may also collect personal information through our affiliates or suppliers. In addition, you may choose to submit information directly to us via several methods, including:

- through LSH and its affiliates' websites
- in response to marketing or other communications
- through social media
- by signing up for LSH or its affiliates' product or service
- through participation in an offer, program or promotion
- in connection with an actual or potential business, or an employment relationship with us
- at events, conferences, meetings and seminars

You may also agree to third parties disclosing information about you to us that those third parties have collected, e.g. from your/our insurance company, via joint agency agreements etc., depending on the services being offered.

We, our service providers and partners collect certain information by using automated means, such as cookies and web beacons, when you interact with our advertisements, mobile applications, or visit our websites, pages or other digital assets. The information we collect in this manner may include: IP address, browser type, operating system, referring URLs and information on actions taken or interaction with our digital assets.

We may use third-party web analytics services on our websites and mobile apps. The analytics providers that administer these services use technologies such as cookies and web beacons to help us analyse how visitors use our websites and apps. The "Rights of the Data Subject" section of this Privacy Notice specifies your ability, to opt out or limit the usage of the information collected, where applicable.

## **Cookies**

The internet pages of LSH and its subsidiaries/branches use cookies. Cookies are text files that are stored in a computer system via an internet browser. Many cookies contain a 'Cookie ID', which is a unique identifier of the cookie consisting of a character string through which internet pages and servers can be assigned to the specific internet browser in which the cookie was stored. This allows visited internet sites and servers to differentiate the individual browser of the data subject from the internet browsers that contain other cookies. A specific internet browser can be recognised and identified using the unique cookie ID. Cookies allow us to recognise our website users, the purpose of this recognition is to make it easier for users to utilise our website. Set cookies may be deleted at any time via an internet browser or other software programs. If a data subject deactivates the cookie setting in the internet browser used, this may result in some functions of our website being unusable. ## **Purposes of collection**

Generally, we will collect, use and hold your information for the purposes of:

- Assessing applications for and providing LSH and its affiliates' products/services
- Conducting business, developing relationships with LSH and its affiliates
- Process payment transactions including: accounting, authorisation, clearing, chargebacks, auditing, billing, reconciliation, collection, complaints, enquiries, credit checks and related dispute resolution activities
- Protect against and prevent fraud, unauthorised transactions, money laundering, tax evasion, claims, other liabilities and manage risk exposure and agent/franchise quality, integrity, compliance and security of business processes
- Create and manage any accounts, associated authentication criteria (ID's and passwords) you may have with LSH
- Provide, administer and communicate with you about LSH products, services, offers, programs and promotions, their issuers, acquirers, retailers and partners.
- Compile business directories, including business contact information
- Operate, monitor, evaluate and improve our products, services, websites, mobile applications, other digital assets and business
- Developing new products and services
- Managing communications, assess effectiveness and optimisation of advertising
- Functionality of our websites, mobile applications other digital assets
- Evaluate your interest in employment and contact you regarding possible employment opportunities
- Enforce LSH Terms of Use, other legal rights as may be required by applicable laws and regulations or requested by any judicial process or governmental agency having or claiming jurisdiction over LSH or its affiliates.
- Comply with industry standards and LSH policies
- In order to provide focused marketing and information, especially with regard to the collection of photography and videography for building/site inspections or marketing purposes.

## Purposes of Collection – Photography/Videography

Lambert Smith Hampton will take photographs of properties/site inspections for the purposes of valuation reports, building/site inspections, property management inspections etc. We have a legitimate interest for taking such photographs as an accurate record of the condition of the property at that time.

Photography and/or videography may also be taken at events, under a legitimate interest, in order to keep a record of the event and/or to use for marketing purposes on social media, our website and other promotional material following the event and for publicity of future events. Any event attendee not wishing to be part of our photography or filming should advise a member of the events team, whose details will also be on your invite at the time. One to one filming/interviews may also take place at such events, where specific informed consent will be sought prior to commencement of the event.

## Rights of the Data Subject (Articles 12-23 of the GDPR)

UK Data Protection Laws afford Data Subjects with rights, which are summarised below. In order to assert any of these rights, the Data Subject may contact the Data Protection Officer listed above, or any LSH employee at any time.

Your rights regarding the sensitive/personal information we maintain about you enable you to exercise choices about what personal information we collect from you, how we use that information, and how we communicate with you.

### Right of Access and Confirmation

You shall have the right to:

- Obtain confirmation that we hold personal information about you and request access to/copies of the personal information we maintain about you.
- Obtain information as to whether personal data are transferred to a third country or to an international organisation. Where this is the case, the data subject shall have the right to be informed of the appropriate safeguards relating to the transfer.

Please note: The right to access personal information may be limited in some circumstances by local law requirements.

### Right to Rectification

If you feel that the information we hold about you is incorrect or inaccurate you can contact us outlining the information you feel is incorrect or inaccurate.

If we refuse to correct your personal information, we will provide you with a written notice that sets out the reasons for our refusal (unless it would be unreasonable to provide those reasons) and provide you with a statement regarding the mechanisms available to you to make a complaint. We will provide you with access to information we hold about you.

### **Right to Object**

If you would like to object to any processing of your information by LSH you can contact us outlining what processing of information you would like to object to.

### **Right to Restrict and Erase (Right to be Forgotten)**

If you would like LSH to delete, block or anonymise information we hold about you, you can contact us outlining what information you would like deleted, blocked or anonymised.

To update your preferences, ask us to remove your information from our mailing lists or submit a request to access, update, correct or delete your personal information, please contact us as specified in the 'Complaints and Feedback' section below.

### **Opting Out of Automated Individual Decision-Making (including profiling)**

You can opt out of personal information collection by automated means e.g. when visiting our website or visiting third-party websites, and interact with our adverts, by using the cookie consent tool displayed in the website (the browser you use may provide options on how to opt out of receiving certain types of cookies). However without cookies you may not be able to use all of the website features and/or online services. Some of our service providers and partners may collect information about your online activities over time and across third-party websites to customise and target our adverts.

You can ask us not to send you marketing communications by:

### **Right to Withdraw Consent**

Where we obtain your personal data by consent, you have the right to withdraw consent to the processing of your personal data at any time.

LSH will apply your preferences going forward. Doing so will mean that you cannot take advantage of certain LSH and affiliate products, services and promotions.

The right to withdraw consent of processing personal data may be limited in some circumstances by local law requirements and you will be informed appropriately where this is the case.

You can exercise your right to prevent data processing by following the instructions on our website pages where we collect your data or alternatively invoke the right to be forgotten by clicking the unsubscribe/stop all email communications link listed on all our email communications, or by writing to us. On receipt of this request we will remove your personal data, where we are required by law to do so, from our central CRM system and all email marketing will cease with immediate effect.

## **Anti-Money Laundering**

In addition, to help you with a property related service, LSH must comply with certain regulations, for example, the Money Laundering, Terrorist Financing and Transfer of Funds (Information on the Payer) Regulations 2017 as amended from time to time (referred to as “the Regulations”). LSH is required to obtain certain information from you to comply with the Regulations. The information provided will only be used by LSH in relation to complying with the Regulations and will not be shared with any other party outside of our group of businesses, unless we are required to do so by law.

If you decide to enter into a business relationship with LSH, to comply with certain regulations, we will require two separate identification documents - one primary and one secondary document even if it appears on both lists. The information may be required at various stages of the process depending whether you are purchasing or selling.

We reserve the right to employ third party electronic verification for the purpose of verifying identity. This search will not affect your credit rating.

## **Lawful bases of processing (Article 6 GDPR)**

LSH processes personal information under the following lawful bases:

- Performance of a contract: where you enter into a contract with LSH or its affiliates and we need to process your information as part of this contract
- Legitimate interests: some information is processed by LSH as part of its legitimate interests which include: fraud, risk assessment, due diligence, network and information security, suppressions and managing opting out of communications, profiling, direct marketing, monitoring, web analytics, cloud storage, acquisitions, updating customer details, lettings, sales, financial services and other core products and service provided by the data controller to carry out our business in favour of the well-being of all of our employees and shareholders
- Public interest: where processing is necessary for the performance of a task carried out in the interest of the public, or in the exercise of official authority.
- Consent: where we process information under consent we will seek clear and unambiguous consent prior to processing your data
- Legal obligation: where processing is necessary in order to fulfil a legal obligation, such as for anti-money laundering due diligence checks
- Vital interests: where personal data may need to be processed/shared in order to uphold the data subject, or other natural persons vital interests

## **Special Category Data Processing (Article 9 GDPR/Schedule 1 DPA 2018)**

Where LSH may be provided with information defined as ‘special category’ personal data, our lawful bases for processing are:

- Explicit consent: your permission has been granted directly to us and documented.

- Purpose of employment and social security: such as complying with employment laws, or processing next of kin details of employees signed up to the company pension scheme.
- Data manifestly made public by the data subject: such as electoral register.
- Establishing, exercising or defending a legal claim: such as litigation against the business or our employee(s).

### Information we share

We do not sell or otherwise disclose personal information we collect about you, except as described in this Privacy Notice. We may share your information within LSH Group of companies and also relevant third parties, as per below, but not limited to:

- Vetted affiliates and partners, such as online bidding platforms for our auctions services
- Landlords and landlord associates and sub processors
- Data Controllers where we have collected your data on their behalf, under contract with them in our capacity as a Data Processor:
  - You are the customer of our client i.e. we are acting on behalf of an insurer who you hold a policy with.
  - You are the tenant/proposed tenant of a property we have let or are marketing to let.
- Formally contracted service providers to perform services on our behalf:
  - Hosting datacentres, infrastructure, applications (development/support), cloud services (software as a service – SaaS, platform as a service – PaaS, infrastructure as a service – IaaS)
  - Helpdesk, call centres etc.
  - Contractors and Sub contractors appointed to undertake necessary works, including utility companies.
  - Employees and other Agents of the Client appointed to undertake necessary works at a development.
  - Solicitors, accountants and other professional bodies instructed on behalf of the Client, including insurance companies.
  - Leasehold Payment Service and Co-Sec Management Services
  - Suppliers appointed to undertake compliance and regulatory activities, such as internal audit.

We contractually require these service providers to safeguard the privacy and security of personal data they process on our behalf and authorise them to use or disclose the information only as necessary to perform services on our behalf or comply with legal requirements:

- Councils, health and care providers, educators and examining bodies
- Other law firms
- Credit agencies, Land Registry Office, Her Majesty's Revenue and Customs (HMRC), Financial Conduct Authority (FCA) and other relevant regulatory bodies
- Additionally, we may share information about you, if required legally, to prevent harm or financial/reputational loss, for investigation of suspected or actual fraudulent or illegal activities, including to insurance companies.
- Prospective employers requesting references via your written consent

Features can be accessed, on websites, where we partner with other entities who are not affiliated with LSH. These include, but are not limited to, social networking, geo-location tools etc. which are operated by third parties (indicated appropriately), who may use or share personal information in accordance with their own privacy policies. It is recommended that you review the third parties' privacy policies if you use such relevant features.

**Data Transfers, Including International and Third Party Data Transfers (DPA 2018 Part 2 Chapter 2 Section 18, Part 3 Chapter 5, Part 7 Chapter 6 Section 207, and GDPR Articles 44-50)**

LSH reserve the right to transfer your information in the event of a sale or transfer (wholly or partially) of our business or assets, with reasonable efforts for the acquirer to protect/use your information consistent with this Privacy Notice. You can exercise your rights to contact the acquiring entity with questions concerning the protection and processing of your information.

Some of our external third party suppliers may be based outside of the UK and EEA, so their processing of your personal data may involve a transfer of data outside of the UK and EEA. Under Data Protection Law, international transfers of personal data may take place if the third country ensures an adequate level of protection, and both controller and processor, provide appropriate safeguards/transfer mechanisms, through means such as International Data Transfer Agreements (IDTA), Standard Contractual Clauses (SCC), or Binding Corporate Rules (BCR), where applicable. Furthermore, legislation provides for derogation clauses, allowing for the transfer to take place, even where neither an adequate level of protection, nor appropriate safeguard is in place.

LSH may transfer the personal information collected about you to recipients in countries other than the country in which the information was originally collected. Those countries may not have the same data protection laws as the country in which you initially provided the information. When we transfer your information to other countries, we will protect that information as described in this Privacy Notice and in full compliance with all aspects of current UK Data Protection Laws and in accordance with the country-specific legislation applicable, or as otherwise disclosed to you at the time the data is collected (e.g. via a program specific privacy notice).

For any transfer of personal data outside the UK/EEA, we aim to ensure a similar degree of data protection is applied following at least one of the following implemented safeguards:

1. We will only transfer personal data to countries that have been deemed to provide an adequate level of protection for personal data by the UK Government (Adequacy Decision).
2. Where we use certain service providers, we may use specific contracts approved by the UK Government in line with the UK Supervisory Authority, which give personal data the same level of protection it has in the UK (IDTA, New EU SCC with UK Addendum, or BCR) for the transfer of personal data to third countries.
3. Where personal data is being transferred to us in the UK by a supplier/service provider outside of the UK (in the EU/EEA), we will ensure that an appropriate transfer mechanism(s) are in place, if/where required.
4. Where we use providers based in the USA, we may transfer data to them as part of a contractual service. Where this is the case, we will ensure adequate transfer contracts are in place in line with Article 46 of the UK GDPR and that an appropriate Transfer Risk Assessment (TRA) has been carried out.

Where we are unable to rely on one of the safeguards outlined above, we may rely on Article 49 of the GDPR – ‘Derogations for specific situations’, when the transfer relates to the performance of a contract at your request or in your interest, where you have given explicit consent, for public interest or legal claims, the vital interest of you or another person. Where your personal data is transferred outside of the UK, controls on data protection may not be as wide as the legal requirements within the UK.

### **Profiling**

For the purposes of business conduct, enhancement, identification of fraud, money laundering and other potential un-authorised activities, LSH engages profiling activities via direct use or anonymisation of sensitive personal information.

#### **Direct profiling**

Direct profiling is engaged for the fair and lawful purposes, to provide LSH the ability to enforce LSH Terms of Use, legal reporting as may be required by applicable laws, regulations, policies/standards or requested by any judicial process or governmental agency having or claiming jurisdiction over LSH or its affiliates; including, but not limited to:

- Benchmarking employees: appraisals, performance, bonus payments, disciplinary actions, improvement plans, promotions and awards
- Background checks for existing and new employees, clients, business partners, affiliates
- Financial Viability analysis/reports
- Business partner/client portfolio position, performance, risk positions
- Anti-money laundering
- Tax reporting
- Credit defaulting exposure

#### **Indirect profiling**

Indirect profiling via anonymisation of personal information is also used for preparing and furnishing aggregated data reports showing anonymised information, including, but not limited to, the following:

- Compilations, analyses, analytical and predictive models and rules, and other aggregated reports for the purpose of advising our partners/affiliates and servicing institutions, retailers and other customers regarding past and potential future patterns of service usage, spending, fraud, and other insights that may be extracted from this data
- Compiling and communicating promotional and marketing information about products and services that LSH Group, affiliates and other organisations that we have affiliations with and that may be of interest to you.
- Conducting market research
- Facilitating our internal business operations, including the fulfilment of any legal requirements.

## **Security of Processing Personal Information (Article 32 GDPR)**

The security of your personal information is very important and LSH is committed to protecting the information we collect. We maintain administrative, technical and physical safeguards designed to protect the personal information you provide, or we collect, against accidental, unlawful or unauthorised destruction, loss, alteration, access, disclosure or use. We use SSL encryption on our websites from which we transfer certain personal information.

Access to personal data is restricted only to those who have a legitimate business need and data processed by third parties is only done so under strict instruction from LSH, as per the terms of their contract.

Procedures are in place to ensure breaches, or suspected breaches, are dealt with in a timely and secure manner with applicable notification applied within the required timeframes set out in accordance with current UK Data Protection Laws.

## **Retention Period**

We will keep your information for as long as is reasonably necessary for the purposes set out in this Privacy Notice, and to fulfill our legal and regulatory obligations. We take measures to securely destroy or permanently de-identify personal information if required by law, or if the personal information is no longer required for the purpose for which we collected it. LSH will generally keep personal information for 7 years after the last contact with you, in line with UK statutory retention periods; however, LSH reserves the right to keep information for longer were we have a regulatory obligation to do so, or if we are required to do so in relation to legal proceedings or the fulfilment of a contract, or any overriding legitimate business interests.

## **Contractual Obligation of the Data Subject/Possible Consequences of Failure to Provide Such Data**

The Data Subject has a contractual obligation to provide personal data to LSH where the provision of personal data is required by law (e.g. tax regulations, Anti-Money Laundering etc.), or can also result from contractual provisions i.e. information on the contractual partner. Sometimes it may be necessary to conclude a contract that the data subject provides us with personal data, which must subsequently be processed by us. The Data Subject is, for example, obliged to provide us with personal data when LSH signs a contract with the Data Subject. The non-provision of the personal data would have the consequence that the contract with the data subject could not be concluded.

## **Data Protection for Employment & Recruitment**

LSH shall collect and process the personal data of applicants for the purpose of the processing of the application procedure. The processing may also be carried out electronically. This is the case, in particular, if an applicant submits corresponding application documents by email or via web application to LSH. If LSH concludes an employment contract with an applicant, the submitted data will be stored for the purpose of processing the employment relationship in compliance with legal

requirements. If no employment contract is concluded with the applicant, we may securely destroy/erase the applicants' data. If an employment applicant is successful, further information on how we process employee data can be found in our Employee Privacy Policy once the employment contract has been agreed.
